

Expert System successfully concludes the issue of a minibond with a nominal value of € 5 million

The bond, reserved for professional investors, has been entirely underwritten by Unicredit S.p.A.

Modena, August 2nd, 2019 - The Artificial Intelligence company Expert System, listed on the AIM Italia market, organised and managed by Borsa Italiana, announces that it has successfully issued a 7-year non-convertible minibond ("**Minibond**") with an overall nominal value of € 5 million and a date of maturity of August 2nd 2026 ("**Repayment Date**"). The Minibond, named "Obbligazioni Expert System 2019-2026" and comprising n. 50 indivisible bonds with a unit nominal amount of € 100,000, has been entirely underwritten by Unicredit S.p.A.

Stefano Spaggiari, Chief Executive Officer of Expert System, commented, "The issue of the minibond pursues the objective of supporting the Group's management and growth requirements. Combining this new minibond with the traditional banking channel and use of the capital market, as has recently happened, we are looking to further diversify our funding sources in order to have a financial structure that is always balanced and focused on the medium-long term."

The Minibond's principal terms and conditions are as follows:

- amount: nominal value € 5,000,000.00
- date issued: August 2nd 2019
- duration: 7 years or until August 2nd 2026, the Repayment Date
- issue price: at par value or equal to 100% of the nominal value of each bond
- interest rate: variable rate equal to Euribor 3M with 0% floor + 2.25% spread
- repayment plan: quarterly amortisation with constant principal and two years of preamortisation
